## Appointment of the new Chief Executive Officer

From June 16, 2017 until the close of the Ordinary General Meeting to be held in January 2018, Yann Delabrière will receive gross fixed compensation of 1,038,000 euros. If his appointment continues beyond that date, the Supervisory Board will reconsider the compensation of the Chief Executive Officer.

## Appointment of the new member of the Executive Board

For his position as a member of the Executive Board, Didier Fontaine will receive an annual gross fixed compensation of 10,000 euros and a unique and deferred compensation in the amount of 500,000 euros, subject to the success of the alternative public tender offer under the conditions specified in the merger agreement between Zodiac Aerospace and Safran signed May 24, 2017.

Didier Fontaine will continue in his position as Administration and Finance Director and his employment contract is maintained without any change of terms<sup>1</sup>. Because of the exceptional services rendered by Mr. Fontaine in upgrading accounting and financial management and in securing bank financing, the Executive Board has approved a bonus to his employment contract<sup>2</sup>.
